

## Preliminary Results of Poll Performed by the Constitutional Review Committee

As of 11/4/02 9 P.M. MST

The following are the results of a poll of Congressional Candidates regarding their willingness to protect American's rights as guaranteed by the United States Constitution and Bill of Rights. With this questionnaire, we included 12 pages of research on the subject with possible solutions to the issue (see end to obtain a copy). The following is the question as posed:

"Americans are worried about their rights and the fact that public officials constantly whittle away at those guaranteed to them. I would like to know if you would be willing to sponsor or support a bill or amendment increasing the penalties for public officials who violate their Oath to support, protect and defend the Constitution?"


Total number of Candidates supporting increasing the penalties for violating the Oath of Office: 107 (75% of those Candidates who responded)

## **Conclusions**

**Note: Remember these are preliminary results** 

Due to the late start and the timing just prior to the election, we did not expect a huge response rate. We fully expect to get more responses over the next week after the hectic election when both Candidates and our new Congressmen will have time to reply.

Another factor for a slow response could very well be the research done which was included. That research was specifically done regarding the question of whether it was actually "treasonous" for a public official to violate his Oath to support the Constitution. Obviously, the average reader, and even some candidates that replied, automatically assume treason is always punishable by death. This is not the case.

This fact *could* very well skew the results, but we were aware of that issue prior to sending this out. Based on our own local surveys, we believe the degree of variance to be between 5 - 10%. We wanted to get this research into the hands of our new congressmen and women for reference anyway.

Strictly based on the data so far, it appears that there would definitely be support for a bill or amendment to increase the penalties for public officials who violate their Oath to "preserve, protect and defend the Constitution of the United States".

Our take on the statistics so far and what these figures and the resulting replies we received mean, we offer the following opinions:

- 1. The greatest percentage of positive response was, of course, from Libertarians. We fully expected this response.
- 2. The percentage of positive responses/negative responses from the larger Democratic and Republican parties indicates that a great deal of support could be had which crosses party boundaries. This is also as we expected as this is a "rights" and accountability issue which at present is high on everyone's minds due to media exposure.
- 3. We have noticed that a number of positive responses (from most parties) mention that they are exmilitary. This makes sense as our military swears the same oath and most military regard the Oath as sacred (as it should be). Anyone who would die for his country rather than break that Oath must feel a little disgusted when faced with blatant violations of it.

4. Although it is too early to tell, it is encouraging to note that we see no major variance in support based on gender or ethnicity. (Using sophisticated data mining we will be able to provide the full demographic details in the final report.)

We will send out our questionnaire to the last nine states on Wednesday and allow two weeks for all the possible replies to come in. We believe this to be a reasonable period to allow for further responses. We will then re-distribute the results with significantly more detail.
