Records and Reports on Monetary Instruments Transactions (Refs & Annos) → § 5314. Records and reports on foreign financial agency transactions

(a) Considering the need to avoid impeding or controlling the export or import of monetary instruments and the need to avoid burdening unreasonably a person making a transaction with a foreign financial agency, the Secretary of the Treasury shall require a resident or citizen of the United States or a person in, and doing business in, the United States, to keep records, file reports, or keep records and file reports, when the resident, citizen, or person makes a transaction or maintains a relation for any person with a foreign financial agency. The records and reports shall contain the following information in the way and to the extent the Secretary prescribes:

(1) the identity and address of participants in a transaction or relationship.

(2) the legal capacity in which a participant is acting.

(3) the identity of real parties in interest.

(4) a description of the transaction.

(b) The Secretary may prescribe--

(1) a reasonable classification of persons subject to or exempt from a requirement under this section or a regulation under this section;

(2) a foreign country to which a requirement or a regulation under this section applies if the Secretary decides applying the requirement or regulation to all foreign countries is unnecessary or undesirable;

(3) the magnitude of transactions subject to a requirement or a regulation under this section;

(4) the kind of transaction subject to or exempt from a requirement or a regulation under this section; and

(5) other matters the Secretary considers necessary to carry out this section or a regulation under this section.

(c) A person shall be required to disclose a record required to be kept under this section or under a regulation under this section only as required by law.

In subsection (a), before clause (1), the words "currency or other", "legitimately", "by regulation", and "directly or indirectly" are omitted as surplus. The words "for any person" are substituted for "on behalf of himself or another" to eliminate unnecessary words.

The words "and to the extent" are substituted for "and in such detail" for clarity. In clauses (1) and (2), the words "participants" and "participant" are substituted for "parties" for consistency. In clause (2), the words "to the transaction or relationship" are omitted as surplus. In clause (3), the words "if one or more of the parties are not acting solely as principals" are omitted as surplus. In clause (4), the words "including the amounts of money, credit, or other property involved" are omitted as surplus.

In subsection (b), the words "or a regulation under this section" are added because of the restatement. The words "or does not apply" and "uniform" in clause (2) are omitted as surplus. In clause (5), the words "carry out" are substituted for "the application of" for consistency.

In subsection (c), the words "produce or otherwise . . . the contents of" and "in compliance with a subpoena or summons duly authorized and issued or . . . may otherwise be" are omitted as surplus. The words "under a regulation" are added because of the restatement.

1. Constitutionality

The foreign reporting requirements of former § 1051 et seq. of this title and implementing regulations were sufficiently tailored to single out transactions which were found to have the greatest potential for circumvention of laws of the United States and which involved substantial amounts of money and were therefore reasonable in light of that statutory purpose and consistent with U.S.C.A. Const. Amend. 4. California Bankers Ass'n v. Shultz, U.S.Cal.1974, 94 S.Ct. 1494, 416 U.S. 21, 39 L.Ed.2d 812. Banks And Banking 2000 16; Searches And Seizures 2010 12

2. Foreign financial account

Because Swiss financial company was a financial institution and evidence established that it accepted credits to and transmitted sums from capital account of foreign corporation to defendant's other domestic and foreign accounts, the capital account fell within the definition of a "financial account" for purposes of the Bank Secrecy Act. 3. Weight and sufficiency of evidence

Evidence that defendant had complete control over foreign corporation's capital account once his profit share was allocated to him and that others involved in the company were not consulted with regard to disbursement of the funds to him demonstrated that he had independent authority to direct payments and thus had an interest in the account requiring him to report it under the Bank Secrecy Act. There was sufficient evidence of defendant's willfulness to support his conviction of willfully failing to maintain records and file reports on foreign financial agency transactions, considering evidence of defendant's efforts to conceal his assets from federal government, his admitted knowledge of and failure to answer question on income tax return concerning signature authority at foreign banks, and reference in return to booklet further outlining responsibilities for reporting foreign bank transactions. The words "and to the extent" are substituted for "and in such detail" for clarity. In clauses (1) and (2), the words "participants" and "participant" are substituted for "parties" for consistency. In clause (2), the words "to the transaction or relationship" are omitted as surplus. In clause (3), the words "if one or more of the parties are not acting solely as principals" are omitted as surplus. In clause (4), the words "including the amounts of money, credit, or other property involved" are omitted as surplus.

In subsection (b), the words "or a regulation under this section" are added because of the restatement. The

In subsection (c), the words "produce or otherwise \ldots the contents of" and "in compliance with a subpoena or summons duly authorized and issued or \ldots may otherwise be" are omitted as surplus. The words "under a regulation" are added because of the restatement.
