-We've scheduled a meeting with you for the reason checked below.


[√] We have no record of receiving your tax return(s) for the period(s) listed at the end of this letter. We need to discuss this matter with you. If you've already filed the return(s), please bring newly signed copies of the returns for the periods listed to our meeting. If you haven't filed your return(s), please bring your completed and signed form(s) with you to our meeting. If you can't come to the meeting, you should call our office immediately and reschedule your appointment.

If you don't meet with or contact us, the law allows us to issue a summons for you to testify, appear, or produce information necessary to prepare your tax return(s) we've listed. If you're convicted of not complying with the summons, the court can fine you up to \$1,000, imprison you for up to a year, or both. The court can also charge you with prosecution costs.

[√] We want to discuss payment for the total amount you owe for the tax period(s) listed at the end of this letter. You should bring payment for the total amount you owe with you to your appointment. If you've already paid, bring proof of payment. If you can't pay what you owe, bring any records that shows your current assets, including income, and expense. We will then analyze your financial status and determine how you can pay the total amount you owe. If you can't meet with us on the date and at the time scheduled, you should call our office immediately and reschedule your appointment.

If you don't make your appointment or reschedule it, we may have to take further action to collect the amount you owe. This may include filing a Notice of Federal Tax Lien and seizing your income, wages, or other assets, as the law allows.
